# DECISION OF THE EEA JOINT COMMITTEE No 41/97 of 10 July 1997

amending Protocol 47 to the EEA Agreement, on the abolition of technical barriers to trade in wine

#### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as adjusted by the Protocol Adjusting the Agreement on the European Economic Area, hereinafter referred to as the Agreement, and in particular Article 98 thereof,

Whereas Protocol 47 to the Agreement was amended by Decision of the EEA Joint Committee No 4/96 of 29 February 1996<sup>1</sup>;

Whereas Council Regulation (EC) No 1547/95 of 29 June 1995 amending Regulation (EEC) No 2332/92 as regards sparkling wines produced in the Community and Regulation (EEC) No 4252/88 on the preparation and marketing of liqueur wines produced in the Community<sup>2</sup> is to be incorporated into the Agreement,

### HAS DECIDED AS FOLLOWS:

#### Article 1

- 1. The following indent shall be added in point 19 (Council Regulation (EEC) No 4252/88) in Appendix 1 of Protocol 47 to the Agreement:

- 2. The following indent shall be added in point 38 (Council Regulation (EEC) No 2332/92) in Appendix 1 of Protocol 47 to the Agreement:
