DECISION OF THE EEA JOINT COMMITTEE No 93/2001

of 13 July 2001

amending Annex II (Technical regulations, standards, testing and certification) and Annex XIII (Transport) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex II to the Agreement was amended by Decision of the EEA Joint Committee No 3/2000 of 4 February 2000¹.
- (2) Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee No 76/2001 of 19 June 2001^2 .
- (3) Commission Directive 2001/2/EC of 4 January 2001 adapting to technical progress Council Directive 1999/36/EC on transportable pressure equipment³ is to be incorporated into the Agreement.
- (4) Commission Decision 2001/107/EC of 25 January 2001 deferring for certain transportable pressure equipment the date of implementation of Council Directive $1999/36/EC^4$ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

The following shall be added in point 6b (Council Directive 1999/36/EC) of Chapter VIII of Annex II to the Agreement:

This Decision shall enter into force on 14 July 2001, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee^{*}.

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Communities*.
