DECISION OF THE EEA JOINT COMMITTEE No 147/2001

of 11 December 2001

amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex I to the Agreement was amended by Decision of the EEA Joint Committee No 131/2001 of 23 November 2001¹.
- (2) Four acts regarding control matters are to be incorporated into the Agreement.
- (3) This Decision is not to apply to Iceland and Liechtenstein,

HAS DECIDED AS FOLLOWS:

Article 1

Part 1.2 of Chapter I of Annex I to the Agreement shall be amended as specified in the Annex to this Decision.

Article 2

The texts of Decisions 2000/685/EC², 2000/715/EC³, 2000/734/EC⁴ and 2000/743/EC⁵ in the Norwegian language, to be published in the EEA Supplement to the Official Journal of the European Communities, shall be authentic.
