DECISION OF THE EEA JOINT COMMITTEE No 90/2007

of 6 July 2007

amending Annex XIII (Transport) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee (1) No 54/2007 of 8 June 2007¹.
- (2) Regulation (EC) No 1592/2002 of the European Parliament and of the Council of 15 July 2002 on common rules in the field of civil aviation and establishing a European Aviation Safety Agency² was incorporated into the Agreement by Decision of the EEA Joint Committee No 179/2004³ of 9 December 2004, with specific adaptations.
- Commission Regulation (EC) No 334/2007 of 28 March 2007 amending Regulation (3) (EC) No 1592/2002 of the European Parliament and of the Council on common rules in the field of civil aviation and establishing a European Aviation Safety Agency⁴ is to be incorporated into the Agreement.
- Commission Regulation (EC) No 335/2007 of 28 March 2007 amending Regulation (4) (EC) No 1702/2003 as regards the implementing rules related to environmental certification of aircraft and related products, parts and appliances⁵ is to be incorporated into the Agreement.
- Commission Regulation (EC) No 375/2007 of 30 March 2007 amending Regulation (5) (EC) No 1702/2003 laying down implementing rules for the airworthiness and environmental certification of aircraft and related products, parts and appliances, as well as for the certification of design and production organisations is to be incorporated into the Agreement.

(6) Commission Regulation (EC) No 376/2007 of 30 March 2007 amending Regulation (EC) No 2042/2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks⁷ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Annex XIII to the Agreement shall be amended as follows:

- 1. The following indent shall be added in point 66n (Regulation (EC) No 1592/2002 of the European Parliament and of the Council):
 - '- **32007 R 0334**: Commission Regulation (EC) No 334/2007 of 28 March 2007 (OJ L 88, 29.3.2007, p. 39).'
- 2. The following indents shall be added in point 66p (Commission Regulation (EC) No 1702/2003):
 - '- **32007 R 0335**: Commission Regulation (EC) No 335/2007 of 28 March 2007 (OJ L 88, 29.3.2007, p. 40),
 - **32007 R 0375**: Commission Regulation (EC) No 375/2007 of 30 March 2007 (OJ L 94, 4.4.2007, p. 3).'
- 3. The following indent shall be added in point 66q (Commission Regulation (EC) No 2042/2003):
 - '- **32007 R 0376**: Commission Regulation (EC) No 376/2007 of 30 March 2007 (OJ L 94, 4.4.2007, p. 18).'

Article 2

The texts of Regulations (EC) Nos 334/2007, 335/2007, 375/2007 and 376/2007 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 7 July 2007, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.
