**DECISION OF THE EEA JOINT COMMITTEE**  
**No 94/2007**

**of 6 July 2007**

**amending Annex XXI (Statistics) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex XXI to the Agreement was amended by Decision of the EEA Joint Committee No 62/2007 of 8 June 2007<sup>1</sup>.
- (2) Commission Regulation (EC) No 224/2007 of 1 March 2007 amending Regulation (EC) No 1216/2003 as regards the economic activities covered by the labour cost index<sup>2</sup> is to be incorporated into the Agreement.
- (3) Commission Regulation (EC) No 294/2007 of 20 February 2007 establishing for 2006 the 'Prodcom list' of industrial products provided for by Council Regulation (EEC) No 3924/91<sup>3</sup> is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

*Article 1*

Annex XXI to the Agreement shall be amended as follows:

1. The following shall be added in point 18h (Commission Regulation (EC) No 1216/2003):  
  
    ', as amended by:  
  
    - **32007 R 0224**: Commission Regulation (EC) No 224/2007 of 1 March 2007 (OJ L 64, 2.3.2007, p. 23).'
2. The present adaptation text in point 18h (Commission Regulation (EC) No 1216/2003) shall become adaptation (a).

3. The following adaptation text shall be inserted after adaptation (a) in point 18h (Commission Regulation (EC) No 1216/2003):  
  
'(b) In Article 4(2) the words "and Norway" shall be added after the word "Sweden".'
4. The following point shall be inserted after point 4ad (Commission Regulation (EC) No 317/2006):  
  
'4ae. **32007 R 0294**: Commission Regulation (EC) No 294/2007 of 20 February 2007 establishing for 2006 the 'Prodcum list' of industrial products provided for by Council Regulation (EEC) No 3924/91 (OJ L 83, 23.3.2007, p. 1).'

#### *Article 2*

The texts of Regulations (EC) Nos 224/2007 and 294/2007 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

#### *Article 3*

This Decision shall enter into force on 7 July 2007, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee\*.

#### *Article 4*

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
