### DECISION OF THE EEA JOINT COMMITTEE No 81/2008

## of 4 July 2008

#### amending Annex IX (Financial services) and Protocol 37 to the EEA Agreement

#### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Articles 98 and 101 thereof,

Whereas:

HAS DECIDED AS FOLLOWS:

# Article 1

Annex IX to the Agreement shall be amended as follows:

The texts of Decisions 2001/527/EC, 2001/528/EC, 2004/5/EC, 2004/6/EC, 2004/7/EC, 2004/8/EC, 2004/9/EC and 2004/10/EC in the Icelandic and Norwegian languages, to be

published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.

# Article 4

This Decision shall enter into force on 5 July 2008, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee<sup>\*</sup>.

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
