DECISION OF THE EEA JOINT COMMITTEE No 84/2008

of 4 July 2008

amending Annex XI (Telecommunication services) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex XI to the Agreement was amended by Decision of the EEA Joint Committee No 67/2008 of 6 June 2008 ¹.
- Commission Decision 2006/771/EC of 9 November 2006 on harmonisation of the (2) radio spectrum for use by short-range devices² is to be incorporated into the Agreement.
- (3) Commission Decision 2006/804/EC of 23 November 2006 on harmonisation of the radio spectrum for radio frequency identification (RFID) devices operating in the ultra high frequency (UHF) band³ is to be incorporated into the Agreement.
- Commission Decision 2007/344/EC of 16 May 2007 on harmonised availability of (4) information regarding spectrum use within the Community⁴ is to be incorporated into the Agreement.
- Commission Recommendation 2005/698/EC of 19 September 2005 on accounting (5) separation and cost accounting systems under the regulatory framework for electronic communications⁵ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Annex XI to the Agreement shall be amended as follows:
