DECISION OF THE EEA JOINT COMMITTEE No 114/2010

of 10 November 2010

amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex I to the Agreement was amended by Decision of the EEA Joint Committee No 60/2010 of 11 June 2010¹.

- of animals and the content of the movement documents ⁶ is to be incorporated into the Agreement.
- (7) Commission Regulation (EC) No 956/2008 of 29 September 2008 amending Annex IV to Regulation (EC) No 999/2001 of the European Parliament and of the Council laying down rules for the prevention, control and eradication of certain transmissible spongiform encephalopathies is to be incorporated into the Agreement.

- (EC) No 1003/2005 as regards the control and testing of *Salmonella* in breeding flocks of *Gallus gallus* and turkeys ¹⁴ is to be incorporated into the Agreement.
- (15) Commission Regulation (EC) No 759/2009 of 19 August 2009 amending the Annex to Council Regulation (EC) No 21/2004 establishing a system for the identification and registration of ovine and caprine animals 15 is to be incorporated into the Agreement.

- disease-free status of Member States, zones and compartments²⁴ is to be incorporated into the Agreement.
- (25) Commission Decision 2009/247/EC of 16 March 2009 amending Decision 2003/322/EC as regards the feeding of certain species of necrophagous birds in Bulgaria with certain category 1 material²⁵ is to be incorporated into the Agreement.
- (26) Commission Decision 2009/722/EC of 29 September 2009 amending Decision 2003/324/EC as regards a derogation from the intra-species recycling ban for the feeding of certain fur animals in Latvia²⁶ is to be incorporated into the Agreement.
- (27) Commission Decision 2009/771/EC of 20 October 2009 approving certain national programmes for the control of salmonella in turkeys²⁷ is to be incorporated into the Agreement.
- (28) Regulation (EC) No 1251/2008 repeals Commission Decisions 1999/567/EC²⁸ and 2003/390/EC²⁹ which are incorporated into the Agreement and are therefore to be repealed under the Agreement.
- (29) Directive 2008/71/EC repeals Council Directive 92/102/EEC³⁰ which is incorporated into the Agreement and is therefore to be repealed under the Agreement.
- (30) Decision 2009/177/EC repeals Commission Decisions 2002/300/EC³¹ and 2002/308/EC³² which are incorporated into the Agreement and are therefore to be repealed under the Agreement.
- (31) Paragraph 2 of the Introductory Part of Chapter I of Annex I specifies that provisions concerning live animals, other than fish and aquaculture animals, shall not apply to Iceland, and that it shall be stated in relation to the specific act when it is not to apply or is to apply partially to Iceland. Therefore, it must be stated in relation to Council Directive 2005/94/EC, which is already incorporated into the Agreement, that it does not apply to Iceland.
- (32) This Decision shall apply to Iceland with the transitional period specified in paragraph 2 of the Introductory Part of Chapter I of Annex I for the areas which did not apply to Iceland prior to the review of this Chapter by Decision of the EEA Joint Committee No 133/2007 of 26 October 2007³³.

HAS DECIDED AS FOLLOWS:

Article 1

Chapter I of Annex I to the Agreement shall be amended as specified in the Annex to this Decision.

Article 2

Article 3

This Decision shall enter into force on 11 November 2010, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
