#### DECISION OF THE EEA JOINT COMMITTEE No 86/2011

# of 1 July 2011

#### amending Annex XX (Environment) to the EEA Agreement

#### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex XX to the Agreement was amended by Decision of the EEA Joint Committee No 57/2011 of 20 May  $2011^{1}$ .
- (2) Commission Regulation (EC) No 748/2009 of 5 August 2009 on the list of aircraft operators which performed an aviation activity listed in Annex I to Directive 2003/87/EC on or after 1 January 2006 specifying the administering Member State for each aircraft operator<sup>2</sup> is to be incorporated into the Agreement.
- (3) Commission Regulation (EU) No 394/2011 of 20 April 2011 amending Regulation (EC) No 748/2009 on the list of aircraft operators that performed an aviation activity listed in Annex I to Directive 2003/87/EC of the European Parliament and of the Council on or after 1 January 2006 specifying the administering Member State for each aircraft operator as regards the expansion of the Union emission trading scheme to EEA-EFTA countries<sup>3</sup> is to be incorporated into the Agreement,

HAS ADOPTED THIS DECISION:

#### Article 1

The following point shall be inserted after point 21ar (Directive 2001/81/EC of the European Parliament and of the Council) of Annex XX to the Agreement:
