

**DECISION OF THE EEA JOINT COMMITTEE**  
**No 230/2013**  
**of 13 December 2013**  
**amending Annex XIII (Transport) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) No 1034/2011 of 17 October 2011 on safety oversight in air traffic management and air navigation services and amending Regulation (EU) No 691/2010 <sup>(1)</sup> is to be incorporated into the EEA Agreement.
- (2) Implementing Regulation (EU) No 1034/2011 repeals Commission Regulation (EC) No 1315/2007 <sup>(2)</sup> which is incorporated into the EEA Agreement and which is consequently to be deleted from the EEA Agreement.
- (3) Annex XIII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

*Article 1*

Annex XIII to the EEA Agreement shall be amended as follows:

- (1) the following indent is added in point 66xa (Commission Regulation (EU) No 691/2010):  
— **32011 R 1034:** Commission Implementing Regulation (EU) No 1034/2011 of 17 October 2011 (OJ L 271, 18.10.2011, p. 15).;
- (2) the following point is inserted after point 66xa (Commission Regulation (EU) No 691/2010):  
‘66xb. **32011 R 1034:** Commission Implementing Regulation (EU) No 1034/2011 of 17 October 2011 on safety oversight in air traffic management and air navigation services and amending Regulation (EU) No 691/2010 (OJ L 271, 18.10.2011, p. 15).;’
- (3) the text of point 66ya (Regulation (EC) No 1315/2007) is deleted.

*Article 2*

The text of Implementing Regulation (EU) No 1034/2011 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

*Article 3*

This Decision shall enter into force on 14 December 2013, provided that all the notifications under Article 103(1) of the EEA Agreement have been made <sup>(\*)</sup> or on the day of the entry into force of Decision of the EEA Joint Committee No 229/2013 of 13 December 2013 <sup>(3)</sup> or on the day of the entry into force of Decision of the EEA Joint Committee No 163/2011 of 19 December 2011 <sup>(4)</sup>, whichever is the later.
