

**DECISION OF THE EEA JOINT COMMITTEE****No 284/2015****of 30 October 2015****amending Annex XX (Environment) to the EEA Agreement [2017/1073]**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Delegated Regulation (EU) 2015/1844 of 13 July 2015 amending Regulation (EU) No 389/2013 as regards the technical implementation of the Kyoto Protocol after 2012 <sup>(1)</sup> is to be incorporated into the EEA Agreement.
- (2) Decision No 406/2009/EC of the European Parliament and of the Council of 23 April 2009 on the effort of Member States to reduce their greenhouse gas emissions to meet the Community's greenhouse gas emission reduction commitments up to 2020 <sup>(2)</sup> has not been incorporated into the EEA Agreement.
- (3) Regulation (EU) No 525/2013 of the European Parliament and of the Council of 21 May 2013 on a mechanism for monitoring and reporting greenhouse gas emissions and for reporting other information at national and Union level relevant to climate change and repealing Decision No 280/2004/EC <sup>(3)</sup> has not been incorporated into the EEA Agreement.
- (4) Annex XX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

*Article 1*

The following is added in point 21ana (Commission Regulation (EU) No 389/2013) of Annex XX to the EEA Agreement:

‘, as amended by:

- **32015 R 1844**: Commission Delegated Regulation (EU) 2015/1844 of 13 July 2015 (OJ L 268, 15.10.2015, p. 1).’

*Article 2*

The texts of Delegated Regulation (EU) 2015/1844 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

*Article 3*

This Decision shall enter into force on 1 November 2015, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (\*).
