# amending Annex XI (Electronic communication, audiovisual services and information society) to the EEA Agreement [2019/1646]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

#### Whereas:

- Commission Implementing Decision (EU) 2017/1438 of 4 August 2017 amending Decision 2007/131/EC on allowing the use of the radio spectrum for equipment using ultra-wideband technology in a harmonised manner in the Community (1) is to be incorporated into the EEA Agreement.
- Commission Implementing Decision (EU) 2017/1483 of 8 August 2017 amending Decision 2006/771/EC on (2) harmonisation of the radio spectrum for use by short-range devices and repealing Decision 2006/804/EC (2) is to be incorporated into the EEA Agreement.
- Implementing Decision (EU) 2017/1483 repeals, with effect from 1 January 2018, Commission Decision (3)2006/804/EC (3), which is incorporated into the EEA Agreement and which is consequently to be repealed under the EEA Agreement with effect from 1 January 2018.
- Annex XI to the EEA Agreement should therefore be amended accordingly, (4)

HAS ADOPTED THIS DECISION:

# Article 1

Annex XI to the EEA Agreement shall be amended as follows:

- (1) The following indent is added in point 5cw (Commission Decision 2007/131/EC):
  - '— 32017 D 1438: Commission Implementing Decision (EU) 2017/1438 of 4 August 2017 (OJ L 205, 8.8.2017, p. 89).'
- (2) The following indent is added in point 5cz (Commission Decision 2006/771/EC):
  - 32017 D 1483: Commission Implementing Decision (EU) 2017/1483 of 8 August 2017 (OJ L 214, 18.8.2017, p. 3).'
- (3) The text of point 5cza (Commission Decision 2006/804/EC) shall be deleted with effect from 1 January 2018.

# Article 2

The texts of Implementing Decisions (EU) 2017/1438 and (EU) 2017/1483 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.
