

DECISION OF THE EEA JOINT COMMITTEE No 24/2019
of 8 February 2019
amending Annex XX (Environment) to the EEA Agreement [2020/941]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Decision (EU) 2018/993 of 11 July 2018 amending Decisions (EU) 2017/1214, (EU) 2017/1215, (EU) 2017/1216, (EU) 2017/1218 and (EU) 2017/1219 as regards the duration of the transitional period ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Annex XX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XX to the EEA Agreement shall be amended as follows:

- (1) the following is added in point 2e (Commission Decision (EU) 2017/1218):

Article 2
