# DECISION OF THE EEA JOINT COMMITTEE No 304/2019

#### of 13 December 2019

# amending Annex IX (Financial Services) to the EEA Agreement [2020/322]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

### Whereas:

- (1) Commission Delegated Regulation (EU) 2017/2358 of 21 September 2017 supplementing Directive (EU) 2016/97 of the European Parliament and of the Council with regard to product oversight and governance requirements for insurance undertakings and insurance distributors (1) is to be incorporated into the EEA Agreement.
- (2) Commission Delegated Regulation (EU) 2017/2359 of 21 September 2017 supplementing Directive (EU) 2016/97 of the European Parliament and of the Council with regard to information requirements and conduct of business rules applicable to the distribution of insurance-based investment products (2) is to be incorporated into the EEA Agreement.
- (3) Commission Delegated Regulation (EU) 2018/541 of 20 December 2017 amending Delegated Regulation (EU) 2017/2358 and Delegated Regulation (EU) 2017/2359 as regards their dates of application (3) is to be incorporated into the EEA Agreement.
- (4) Commission Implementing Regulation (EU) 2017/1469 of 11 August 2017 laying down a standardised presentation format for the insurance product information document (4) is to be incorporated into the EEA Agreement.
- (5) Annex IX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

## Article 1

The following points are inserted after point 13e (Directive (EU) 2016/97 of the European Parliament and of the Council) of Annex IX to the EEA Agreement:

## Article 2

The texts of Delegated Regulations (EU) 2017/2358, (EU) 2017/2359, (EU) 2018/541 and Implementing Regulation (EU) 2017/1469 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.

### Article 3

This Decision shall enter into force on 14 December 2019, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (\*), or on the day of the entry into force of Decision of the EEA Joint Committee No 214/2018 of 26 October 2018 (5), whichever is the later.

#### Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the Official Journal of the European Union.
