DECISION OF THE EEA JOINT COMMITTEE No 306/2019

of 13 December 2019

amending Annex IX (Financial Services) to the EEA Agreement [2020/324]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof.

Article 2

The texts of Delegated Regulations (EU) 2016/522, (EU) 2016/908, (EU) 2016/909, (EU) 2016/957, (EU) 2016/958, as corrected by OJ L 110, 27.4.2017, p. 9, (EU) 2016/960, (EU) 2016/1052, (EU) 2019/461, as corrected by OJ L 103, 12.4.2019, p. 61, Implementing Regulations (EU) 2016/347, (EU) 2016/378, (EU) 2016/523, (EU) 2016/959, (EU) 2016/1055, (EU) 2017/1158, (EU) 2018/292 and Implementing Directive (EU) 2015/2392 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.

Article 3

This Decision shall enter into force on 14 December 2019, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*), or on the day of the entry into force of Decision of the EEA Joint Committee No 259/2019 of 25 October 2019 (17), whichever is the later.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the Official Journal of the European Union.
