## DECISION OF THE EEA JOINT COMMITTEE No 44/2022

## of 23 February 2022

# amending Annex V (Free movement of workers) and Annex VIII (Right of establishment) to the EEA Agreement [2022/1112]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

#### Whereas:

- (1) Commission Implementing Decision (EU) 2021/2187 of 9 December 2021 establishing the equivalence, for the purpose of facilitating the right of free movement within the Union, of COVID-19 certificates issued by the Republic of Lebanon to the certificates issued in accordance with Regulation (EU) 2021/953 of the European Parliament and of the Council (1) is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Decision (EU) 2021/2188 of 9 December 2021 establishing the equivalence, for the purpose of facilitating the right of free movement within the Union, of COVID-19 certificates issued by the United Arab Emirates to the certificates issued in accordance with Regulation (EU) 2021/953 of the European Parliament and of the Council (²) is to be incorporated into the EEA Agreement.
- (3) Commission Implementing Decision (EU) 2021/2189 of 9 December 2021 establishing the equivalence, for the purpose of facilitating the right of free movement within the Union, of COVID-19 certificates issued by the Republic of Cabo Verde to the certificates issued in accordance with Regulation (EU) 2021/953 of the European Parliament and of the Council (3) is to be incorporated into the EEA Agreement.
- (4) Annexes V and VIII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:
