DECISION OF THE EEA JOINT COMMITTEE

No 149/2015

of 11 June 2015

amending Annex II (Technical regulations, standards, testing and certification) to the EEA Agreement [2016/2184]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2015/149 of 30 January 2015 amending the Annex to Regulation (EU) No 37/2010 as regards the substance 'methylprednisolone' (1) is to be incorporated into the EEA Agreement.
- Commission Implementing Regulation (EU) 2015/150 of 30 January 2015 amending the Annex to Regulation (2) (EU) No 37/2010 as regards the substance 'gamithromycin' (2) is to be incorporated into the EEA Agreement.
- Commission Implementing Regulation (EU) 2015/151 of 30 January 2015 amending the Annex to Regulation (3) (EU) No 37/2010 as regards the substance 'doxycycline' (3) is to be incorporated into the EEA Agreement.
- Commission Implementing Regulation (EU) 2015/152 of 30 January 2015 amending the Annex to Regulation (4)(EU) No 37/2010, as regards the substance 'tulathromycin' (4) is to be incorporated into the EEA Agreement.
- Annex II to the EEA Agreement should therefore be amended accordingly, (5)

HAS ADOPTED THIS DECISION:

Article 1

The following indents are added in point 13 (Commission Regulation (EU) No 37/2010) of Chapter XIII of Annex II to the EEA Agreement:

- '— 32015 R 0149: Commission Implementing Regulation (EU) 2015/149 of 30 January 2015 (OJ L 26, 31.1.2015, p. 7),
