

DECISION OF THE EEA JOINT COMMITTEE
No 128/2018

of 6 July 2018

amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”),
and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2018/353 of 9 March 2018 correcting Implementing Regulation (EU) 2017/1145 on the withdrawal from the market of certain feed additives authorised pursuant to Council Directives 70/524/EEC and 82/471/EEC and repealing the obsolete provisions authorising those feed additives¹ is to be incorporated into the EEA Agreement.
- (2) Implementing Regulation (EU) 2018/353 of 9 March 2018 states that Commission Regulation (EC) No 1443/2006² was erroneously repealed. As Commission Regulation (EC) No 1443/2006 was repealed by Decision of the EEA Joint Committee No 194/2017, it is consequently to be reincorporated into the EEA Agreement.
- (3) Implementing Regulation (EU) 2018/353 of 9 March 2018 repeals Commission Regulation (EC) No 1459/2005³ which is incorporated into the EEA Agreement and which is consequently to be repealed under the EEA Agreement.
- (4) This Decision concerns legislation regarding feedingstuffs. Legislation regarding feedingstuffs shall not apply to Liechtenstein as long as the application of the Agreement between the European Community and the Swiss Confederation on trade in agricultural products is extended to Liechtenstein, as specified in the sectoral adaptations to Annex I to the EEA Agreement. This Decision is therefore not to apply to Liechtenstein.
- (5) Annex I to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Chapter II of Annex I to the EEA Agreement shall be amended as follows:

1. The following point is inserted after point 1zzx (Commission Regulation (EC) No 1284/2006):

‘1zzy. **32006 R 1443**: Commission Regulation (EC) No 1443/2006 of 29 September 2006 concerning the permanent authorisations of certain additives in feedingstuffs and an authorisation for 10 years for a coccidiostat (OJ L 271, 30.9.2006, p. 235), as amended by:

- **32009 R 0887**: Commission Regulation (EC) No 887/2009 of 25 September 2009 (OJ L 254, 26.9.2009, p.68),
- **32017 R 1145**: Commission Implementing Regulation (EU) 2018/353 of 9 March 2018 (OJ L 68, 12.3.2018, p. 3).’

2. The following is added in point 208 (Commission Implementing Regulation (EU) 2017/1145):

‘, as amended by:

- **32018 R 0353**: Commission Implementing Regulation (EU) 2018/353 of 9 March 2018 (OJ L 68, 12.3.2018, p. 3).’

3. The text of point lzzp (Commission Regulation (EC) No 1459/2005) is deleted.

Article 2

The text of Implementing Regulation (EU) 2018/353 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 7 July 2018, provided that all the notifications under Article 103(1) of the EEA Agreement have been made*.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
