

DECISION OF THE EEA JOINT COMMITTEE
No 142/2018

of 6 July 2018

**amending Annex II (Technical regulations, standards, testing and certification) to the
EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”),
and in particular Article 98 thereof,

Whereas:

- (1) Commission Regulation (EU) 2018/588 of 18 April 2018 amending Annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) as regards 1-methyl-2-pyrrolidone¹ is to be incorporated into the EEA Agreement.
- (2) Commission Regulation (EU) 2018/589 of 18 April 2018 amending Annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) as regards methanol², as corrected by OJ L 102, 23.4.2018, p. 99, is to be incorporated into the EEA Agreement.
- (3) Annex II to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

The following indents are added in point 12zc (Regulation (EC) No 1907/2006 of the European Parliament and of the Council) of Chapter XV of Annex II to the EEA Agreement:

- ‘- **32018 R 0588**: Commission Regulation (EU) 2018/588 of 18 April 2018 (OJ L 99, 19.4.2018, p. 3),
- **32018 R 0589**: Commission Regulation (EU) 2018/589 of 18 April 2018 (OJ L 99, 19.4.2018, p. 7), as corrected by OJ L 102, 23.4.2018, p. 99.’

Article 2

The texts of Regulations (EU) 2018/588 and (EU) 2018/589, as corrected by OJ L 102, 23.4.2018, p. 99, in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.
