#### DECISION OF THE EFTA-LEBANON JOINT COMMITTEE

No. 3 of 2009

(Adopted on 8 October 2009)

# AMENDMENTS TO PROTOCOL A CONCERNING PROCESSED AGRICULTURAL PRODUCTS

#### THE JOINT COMMITTEE,

Having regard to Article 5 of Protocol A, providing that the EFTA States and Lebanon shall grant each other treatment no less favourable than that accorded to the European Community for the products listed in Tables II to V, except for certain products listed in the Article,

Having regard to Article 6 of Protocol A, providing that no later than five years after the entry into force of the Agreement, the Parties shall carry out a review of the exceptions provided for in Article 5 with a view to eliminating such exceptions,

Having regard to Article 8 of Protocol A, providing that the EFTA States and Lebanon shall review periodically the development of their trade in products covered by the Protocol,

Taking into account that the EFTA States have revised their agreements with the European Community on processed agricultural products, by expanding the product coverage of these agreements and providing for improved concessions for the products covered, and are ready to grant improved concessions for products covered by Protocol A,

Taking into account that Lebanon is in a position to grant the EFTA States improved treatment for certain products covered by the Protocol,

Noting that the amendments to the Nomenclature appended to the International Convention on the Harmonized Commodity Description and Coding System (HS), which entered into force on 1 January 2007, require adjustments in the HS structure of the Protocol.

Having regard to paragraph 1 of Article 36 of the Agreement, empowering the Joint Committee to amend the Annexes and Protocols to the Agreement,

# **DECIDES**:

- 1. Protocol A and Tables I, II, III, IV and V to the Protocol shall be replaced by the text and the Tables set out in the Annex to this Decision.
- 2. This Decision shall enter into force on the first day of the third month after the last Party has notified the Depositary that its internal requirements have been fulfilled.
- 3. The Secretary-General of the European Free Trade Association shall deposit the text of this Decision with the Depositary.

#### PROTOCOL A

#### REFERRED TO IN PARAGRAPH 1(b) OF ARTICLE 4

# PROCESSED AGRICULTURAL PRODUCTS

#### Article 1

- 1. In order to take account of differences in the cost of the agricultural raw materials incorporated into the products referred to in Articles 2 and 3 of this Protocol, this Agreement does not preclude:
  - (a) the levying, upon import, of a fixed duty;
  - (b) the application of measures adopted upon export.
- 2. The fixed duties, levied upon import, shall be based on, but not exceed, the differences between the domestic price and the world market price of the agricultural raw materials incorporated into the products concerned.

#### Article 2

For products listed in Table I, originating in Lebanon, Iceland, Liechtenstein/Switzerland and Norway shall accord the concessions listed in the Table.

#### Article 3

For products listed in Table II, originating in an EFTA State, Lebanon shall accord the concessions listed therein.

#### Article 4

Taking into account the provisions laid down in Article 1 of this Protocol, the Parties shall grant each other treatment no less favourable than that accorded to the European Community for the products listed in Tables I and II except for products of HS headings 0403.10, 2004.10 and 2005.20.

#### Article 5

No later than five years after the entry into force of this Agreement, the Parties shall carry out a review of the exceptions provided for in Article 4 with a view to eliminating such exceptions.

# Article 6

- 1. The EFTA States shall notify Lebanon and Lebanon shall notify the EFTA States of all measures applied under Article 1 of this Protocol, at an early stage before their entry into force.
- 2. Lebanon and the EFTA States shall inform each other of all changes in the treatment accorded to the European Community.

# Article 7

The EFTA States and Lebanon shall review periodically the development of their trade in products covered by this Protocol. In the light of these reviews and taking into account the arrangements between the Parties and the European Community or in WTO, the EFTA States and Lebanon shall decide on possible changes to the product coverage of this Protocol, as well as on a possible development of the measures applied under Article 1 of this Protocol.

Notwithstanding the rules for the implementation of the Lebanese customs Nomenclature, the wording of the description of the products is to be considered as having no more than an

indicative value, the preferential scheme being determined, within the context of this Annex, by the coverage of the Lebanese customs code. Where ex codes are indicated, the preferential scheme is to be determined by application of the code and description taken together.

The reduction in column B of the customs duty in A shall neither apply to the minimum duty nor to the excise duty in C.
