COMMITMENTS OF ICELAND ON GOODS ORIGINATING IN CHILE

The following terms and conditions shall apply to the tariff commitments granted by Iceland in accordance with the schedule of tariff concessions in this Annex:

- (a) Upon entry into force of the Agreement, Iceland shall eliminate import duties and charges having equivalent effect to import duties on imports of goods originating in Chile, classified as “NAMA”, as set out below.
- (b) Upon entry into force of the Agreement, Iceland shall, for goods classified as “AG” (Agricultural Products) originating in Chile, apply the customs duties set out in columns 4a (“Ad valorem”) and 4b (“Specific ISK/kg or ISK/piece”) of the table. “NC” means “No Commitment”.
- (c) The classification of goods shall be that set out in the respective tariff nomenclature of Iceland and in conformity with the Harmonized Commodity Description and Coding System (HS 2022).
