PRODUCT-SPECIFIC RULES

SECTION I

INTERPRETATIVE NOTES

1. The product-specific rules (PSR) of origin set out in this Appendix are based on HS 2022. The first column of the list contains chapters, headings or sub-headings and the second column sets out a description of the products. For each entry in the first two columns, one or two rules are specified in column 3. If the HS code in column 1 is preceded by an “ex”, this means that the rules in column 3 apply only to the part of that chapter, heading or sub-heading described in column 2. Where, for an entry in the first two columns, more than one rule is specified in column 3, either one may be applied.
2. The PSR may be fulfilled by operations in more than one company within a Party, if these operations, taken together, fulfil the requirements of Annex I (Rules of Origin and Administrative Cooperation).
3. A PSR of origin set out in this Appendix represents the minimum amount of working or processing required to be carried out on non-originating materials for the final product to achieve originating status. A greater amount of working or processing than that required by the rule shall also confer originating status.
4. If a PSR in the list specifies that a product may be manufactured from more than one material, any one or more materials may be used. It does not require that all be used.
5. If a PSR in the list specifies that a product must be manufactured from a particular material, the condition does not prevent the use of other materials in addition.
6. If a PSR excludes materials classified in certain chapters, headings, or sub-headings, those materials must be originating for the products to qualify as originating.
7. If a product, which has acquired originating status by fulfilling the conditions set out in the list, is used as material in the manufacture of another product, the conditions applicable to the final product do not apply to that material. No account shall be taken of the non-originating components of that material.
8. If a PSR uses the expression “Manufacture from materials of any heading”, then materials of any heading, even materials of the same description and heading as the final product, may be used, subject to any specific limitations which may also be contained in the PSR.
9. The products mentioned in the list do benefit from preferential treatment, subject to the schedules of tariff commitments.

SECTION II

NOTE REFERRING TO CHAPTERS 27 TO 40

1. If a substantial transformation of a molecule has occurred, the origin of the product concerned shall correspond to the Party where that transformation took place.
2. The main method for determination of origin should normally be the rule of change of tariff classification. If that rule cannot be applied, the alternative approaches shall be applied in the following sequence:
 - (a) chemical reaction;
 - (b) mixing and blending;
 - (c) purification;
 - (d) change in particle size;
 - (e) standard materials;
 - (f) isomer separation.
3. For the purposes of paragraph 2:
 - (a) “change in particle size” means, for the purposes of chapters 30 to 32 and heading 38.22: deliberate and controlled modification in particle size of a product, other than by merely crushing or pressing, resulting in a product having a defined particle size, defined particle size distribution or defined surface area, which are relevant to the purposes of the resulting product and have different physical or chemical characteristics from the input materials;
 - (b) “chemical reaction” means a process, including a biochemical process, which results in a molecule with a new structure by breaking intramolecular bonds and by forming new intramolecular bonds, or by altering the spatial arrangement of the molecule. A chemical reaction may also be expressed by a change of the “CAS number”. It does not mean:
 - (i) dissolving in water or other solvents;
 - (ii) elimination of solvents including solvent water; or
 - (iii) addition or elimination of water of crystallisation;
 - (c) “isomer separation” means, for the purposes of chapters 28 to 32, chapter 35 and heading 38.22: isolation or separation of isomers from a mixture of isomers;
 - (d) “mixing and blending” means, for the purposes of chapters 30 to 32,

heading 33.02, subheading 3502.20, headings 35.06 to 35.07, heading 37.07, 38.08 and 38.22: deliberate and proportionally controlled mixing or blending (including dispersing) of materials to conform to predetermined specifications which results in the production of a product having physical or chemical characteristics which are relevant to the purposes or uses of the product and are different from the input materials;

- (e) “purification” means, for the purposes of chapters 28 to 35 and chapter 38:
 - (i) purification of a product resulting in the elimination of 80 % of the content of existing impurities; or
 - (ii) reduction or elimination of impurities resulting in a product suitable for one or more of the following applications:
 - (aa) pharmaceutical, medicinal, cosmetic, veterinary or food grade substances;
 - (bb) chemical products and reagents for analytical, diagnostic or laboratory uses;
 - (cc) elements and components for use in micro-elements;
 - (dd) specialised optical uses;
 - (ee) non-toxic uses for health and safety;
 - (ff) biotechnical use;
 - (gg) carriers used in a separation process; or
 - (hh) nuclear grade uses; and
- (f) “standard materials”, for the purposes of chapters 28 to 32, chapter 35 and chapter 38: production of preparations suitable for analytical, calibrating or referencing uses having precise degrees of purity or proportions which are certified by the manufacturer.
