EU/EEA law.

- “perhaps the most complicated legal structure that has ever been devised and made effective in man’s effort to govern himself.”
- (Griswold, Law and Lawyers in the United States, The Common Law Under Stress, (1964) 238)

Role of the EFTA Court

- Jurisdiction laid out in Articles 31 to 39 SCA.
 - Infringement cases (Article 31 SCA)
 - Advisory Opinions (Article 34 SCA).
 - Direct actions (Article 36 SCA).

Relationship with the CJEU

- Similar jurisdiction with regard to the EFTA States as of the CJEU in relation to EU Member States.
 - Infringement cases (Article 258 TFEU)
 - Preliminary references (Article 267 TFEU).
 - Direct actions (Article 263 TFEU).

Perceptions of the EEA Courts.

- The CJEU is portrayed as:
 - Driven by political agendas.
 - Undemocratic.
 - Too powerful.
 - Biased in favour of EU institutions.

Perceptions of the EEA Courts.

- The EFTA Court is portrayed as:
 - Driven by political agendas.
 - Undemocratic.
 - Too small, with too few cases.
 - Even harsher on the States than the CJEU.

Institutional benefits of an independent EFTA Court.

- Shorter backlog - less risk of bias to the judicial docket.
- More effective use of the legal resources of the EFTA States.
- Role of CJEU is being changed radically.
- Composition.
