DECISION OF THE EEA JOINT COMMITTEE
No 71/2000

of 2 October 2000

amending Annex I (Veterinary and Phytosanitary Matters)
to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as adjusted by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex I to the Agreement was amended by Decision of the EEA Joint Committee No 101/1999 of 24 September 1999¹.
- (2) The EEA relevant EC acts in the field of feedingstuffs adopted between 1 January 1998 and 31 July 1999 are to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Chapter II of Annex I to the Agreement shall be amended as specified in the Annex to this Decision.

Article 3

Dates concerning the entry into force or implementation of the acts mentioned in the Annex to this Decision, shall, for the purposes of the Agreement, be read as follows:

- where the date of entry into force or implementation of the act precedes the date of entry into force of this Decision, the date of entry into force of this Decision shall apply,
- where the date of entry into force or implementation of the act is after the date of entry into force of this Decision, the date of entry into force or implementation of the act shall apply.

Article 4

This Decision shall enter into force on 25 December 2000, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.

Article 5

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Communities*.
