DECISION OF THE EEA JOINT COMMITTEE
No 143/2003

of 7 November 2003

amending Annex II (Technical regulations, standards, testing and certification)
to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex II to the Agreement was amended by Decision of the EEA Joint Committee No 107/2003 of 26 September 2003¹.
- (2) Commission Regulation (EC) No 545/2003 of 27 March 2003 amending Regulation (EEC) No 94/92 laying down detailed rules for implementing the arrangements for imports from third countries provided for in Council Regulation (EEC) No 2092/91² is to be incorporated into the Agreement.
- (3) Commission Regulation (EC) No 599/2003 of 1 April 2003 amending Regulation (EEC) No 2092/91 on organic production of agricultural products and indications referring thereto on agricultural products and foodstuffs³ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

The following indents shall be added in point 54b (Council Regulation (EEC) No 2092/91) of Chapter XII of Annex II to the Agreement:

- ‘- **32003 R 0545**: Commission Regulation (EC) No 545/2003 of 27 March 2003 (OJ L 81, 28.3.2003, p. 10),
- **32003 R 0599**: Commission Regulation (EC) No 599/2003 of 1 April 2003 (OJ L 85, 2.4.2003, p. 15).’

Article 2
