DECISION OF THE EEA JOINT COMMITTEE
No 145/2004

of 29 October 2004

amending Annex II (Technical regulations, standards, testing and certification)
to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Article 98 thereof,

Whereas:

- (1) Annex II to the Agreement was amended by Decision of the EEA Joint Committee No 126/2004 of 24 September 2004¹.
- (2) Commission Regulation (EC) No 324/2004 of 25 February 2004 amending Annex I to Council Regulation (EEC) No 2377/90 laying down a Community procedure for the establishment of maximum residue limits of veterinary medicinal products in foodstuffs of animal origin² is to be incorporated into the Agreement.
- (3) Commission Regulation (EC) No 546/2004 of 24 March 2004 amending Annexes I, II and III to Council Regulation (EEC) No 2377/90 laying down a Community procedure for the establishment of maximum residue limits of veterinary medicinal products in foodstuffs of animal origin³ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

The following indents shall be added in point 14 (Council Regulation (EEC) No 2377/90) of Chapter XIII of Annex II to the Agreement:

- ‘- **32004 R 0324**: Commission Regulation (EC) No 324/2004 of 25 February 2004 (OJ L 58, 26.2.2004, p. 16),
- **32004 R 0546**: Commission Regulation (EC) No 546/2004 of 24 March 2004 (OJ L 87, 25.3.2004, p. 13).’

Article 2
