DECISION OF THE EEA JOINT COMMITTEE
No 113/2006

of 22 September 2006

amending Annex II (Technical regulations, standards, testing and certification)
to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex II to the Agreement was amended by Decision of the EEA Joint Committee No 79/2006 of 7 July 2006¹.
- (2) Commission Regulation (EC) No 1294/2005 of 5 August 2005 amending Annex I to Council Regulation (EEC) No 2092/91 on organic production of agricultural products and indications referring thereto on agricultural products and foodstuffs² is to be incorporated into the Agreement
- (3) Commission Regulation (EC) No 1318/2005 of 11 August 2005 amending Annex II of Council Regulation (EEC) No 2092/91 on organic production of agricultural products and indications referring thereto on agricultural products and foodstuffs³ is to be incorporated into the Agreement.
- (4) Commission Regulation (EC) No 1336/2005 of 12 August 2005 amending Annex III to Council Regulation (EEC) No 2092/91 on organic production of agricultural products and indications referring thereto on agricultural products and foodstuffs⁴ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

The following indents shall be added in point 54b (Council Regulation (EEC) No 2092/91) of Chapter XII of Annex II to the Agreement:

- ‘- **32005 R 1294**: Commission Regulation (EC) No 1294/2005 of 5 August 2005 (OJ L 205, 6.8.2005, p. 16),
- **32005 R 1318**: Commission Regulation (EC) No 1318/2005 of 11 August 2005 (OJ L 210, 12.8.2005, p. 11),
- **32005 R 1336**: Commission Regulation (EC) No 1336/2005 of 12 August 2005 (OJ L 211, 13.8.2005, p. 11).’

Article 2

The texts of Regulations (EC) Nos 1294/2005, 1318/2005 and 1336/2005 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

This Decision shall enter into force on 23 September 2006, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.
