DECISION OF THE EEA JOINT COMMITTEE
No 58/2007

of 8 June 2007

amending Annex XX (Environment) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex XX to the Agreement was amended by Decision of the EEA Joint Committee No 36/2007 of 27 April 2007¹.
- (2) Regulation (EC) No 166/2006 of the European Parliament and of the Council of 18 January 2006 concerning the establishment of a European Pollutant Release and Transfer Register and amending Council Directives 91/689/EEC and 96/61/EC² is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Annex XX to the Agreement shall be amended as follows:

1. The following point shall be inserted after point 1g (Directive 2001/42/EC of the European Parliament and of the Council):

 '1h. **32006 R 0166:** Regulation (EC) No 166/2006 of the European Parliament and of the Council of 18 January 2006 concerning the establishment of a European Pollutant Release and Transfer Register and amending Council Directives 91/689/EEC and 96/61/EC (OJ L 33, 4.2.2006, p. 1).'
2. The following shall be added in point 1f (Council Directive 96/61/EC):

 ', as amended by:

 - **32006 R 0166:** Regulation (EC) No 166/2006 of the European Parliament and of the Council of 18 January 2006 (OJ L 33, 4.2.2006, p. 1).'

3. The following indent shall be added in point 32a (Council Directive 91/689/EEC):
- ‘- **32006 R 0166**: Regulation (EC) No 166/2006 of the European Parliament and of the Council of 18 January 2006 (OJ L 33, 4.2.2006, p. 1).’

Article 2

The texts of Regulation (EC) No 166/2006 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 9 June 2007, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
