DECISION OF THE EEA JOINT COMMITTEE
No 159/2007

of 7 December 2007

amending Annex VI (Social security) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Article 98 thereof,

Whereas:

- (1) Annex VI to the Agreement was amended by Decision of the EEA Joint Committee No 132/2007 of 26 October 2007¹.
- (2) Regulation (EC) No 1992/2006 of the European Parliament and of the Council of 18 December 2006 amending Council Regulation (EEC) No 1408/71 on the application of social security schemes to employed persons, to self-employed persons and to members of their families moving within the Community² is to be incorporated into the Agreement.
- (3) Commission Regulation (EC) No 311/2007 of 19 March 2007 amending Council Regulation (EEC) No 574/72 laying down the procedure for implementing Regulation (EEC) No 1408/71 on the application of social security schemes to employed persons, to self-employed persons and to members of their families moving within the Community³ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Annex VI to the Agreement shall be amended as follows:

1. The following indent shall be added in point 1 (Council Regulation (EEC) No 1408/71):
 - ‘- **32006 R 1992**: Regulation (EC) No 1992/2006 of the European Parliament and of the Council of 18 December 2006 (OJ L 392, 30.12.2006, p. 1).’

2. The following indent shall be added in point 2 (Council Regulation (EEC) No 574/72):

‘- **32007 R 0311**: Commission Regulation (EC) No 311/2007 of 19 March 2007 (OJ L 82, 23.3.2007, p. 6).’

Article 2

The texts of Regulations (EC) Nos 1992/2006 and 311/2007 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 8 December 2007, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
