**DECISION OF THE EEA JOINT COMMITTEE**  
**No 87/2008**

**of 4 July 2008**

**amending Annex XIII (Transport) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Article 98 thereof,

Whereas:

- (1) Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee No 72/2008 of 6 June 2008<sup>1</sup>.
- (2) Regulation (EC) No 2320/2002 of the European Parliament and of the Council of 16 December 2002 establishing common rules in the field of civil aviation security<sup>2</sup> was incorporated into the Agreement by Decision of the EEA Joint Committee No 61/2004 of 26 April 2004<sup>3</sup>, with country specific adaptations.
- (3) Commission Regulation (EC) No 1477/2007 of 13 December 2007 amending Regulation (EC) No 622/2003 laying down measures for the implementation of the common basic standards on aviation security<sup>4</sup> is to be incorporated into the Agreement.
- (4) Commission Regulation (EC) No 23/2008 of 11 January 2008 amending Regulation (EC) No 622/2003 laying down measures for the implementation of the common basic standards on aviation security<sup>5</sup> is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

*Article 1*

The following indents shall be added in point 66i (Commission Regulation (EC) No 622/2003) of Annex XIII to the Agreement:
