DECISION OF THE EEA JOINT COMMITTEE
No 89/2008

of 4 July 2008

amending Annex XX (Environment) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Article 98 thereof,

Whereas:

- (1) Annex XX to the Agreement was amended by Decision of the EEA Joint Committee No 73/2008 of 6 June 2008¹.
- (2) Commission Decision 2008/63/EC of 20 December 2007 amending Decisions 2002/231/EC, 2002/255/EC, 2002/272/EC, 2002/371/EC, 2003/200/EC and 2003/287/EC in order to prolong the validity of the ecological criteria for the award of the Community eco-label to certain products² is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Annex XX to the Agreement shall be amended as follows:

1. The following indent shall be added in points 2g (Commission Decision 2002/231/EC), 2j (Commission Decision 2002/255/EC), 2k (Commission Decision 2002/272/EC) and 2f (Commission Decision 2002/371/EC):

2. The following shall be added in points 2e (Commission Decision 2003/200/EC) and 2m (Commission Decision 2003/287/EC):

Article 2

The texts of Decision 2008/63/EC in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 5 July 2008, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
