DECISION OF THE EEA JOINT COMMITTEE
No 118/2010

of 10 November 2010

amending Annex II (Technical regulations, standards, testing and certification)
to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Article 98 thereof,

Whereas:

- (1) Annex II to the Agreement was amended by Decision of the EEA Joint Committee No 138/2009 of 4 December 2009¹.
- (2) Commission Decision 2009/251/EC of 17 March 2009 requiring Member States to ensure that products containing the biocide dimethylfumarate are not placed or made available on the market² is to be incorporated into the Agreement.
- (3) Commission Decision 2010/153/EU of 11 March 2010 prolonging the validity of Decision 2009/251/EC requiring Member States to ensure that products containing the biocide dimethylfumarate are not placed or made available on the market³ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

The following shall be inserted after point 3m (Commission Decision 2008/357/EC) of Chapter XIX of Annex II to the Agreement:

- ‘3n. **32009 D 0251**: Commission Decision 2009/251/EC of 17 March 2009 requiring Member States to ensure that products containing the biocide dimethylfumarate are not placed or made available on the market (OJ L 74, 20.3.2009, p. 32), as amended by:
- **32010 D 0153**: Commission Decision 2010/153/EU of 11 March 2010 (OJ L 63, 12.3.2010, p. 21).’

Article 2

The texts of Decisions 2009/251/EC and 2010/153/EU in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.
