# DECISION OF THE EEA JOINT COMMITTEE No 103/2011

# of 30 September 2011

# amending Annex XIII (Transport) to the EEA Agreement

### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

### Whereas:

- (1) Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee No 90/2011 of 19 July 2011<sup>1</sup>.
- (2) Commission Decision 2010/713/EU of 9 November 2010 on modules for the procedures for assessment of conformity, suitability for use and EC verification to be used in the technical specifications for interoperability adopted under Directive 2008/57/EC of the European Parliament and of the Council<sup>2</sup> is to be incorporated into the Agreement,

## HAS ADOPTED THIS DECISION:

#### Article 1

The following point shall be inserted after point 37dc (Commission Decision 2009/965/EC) of Annex XIII to the Agreement:

'37dd. **32010 D 0713**: Commission Decision 2010/713/EU of 9 November 2010 on modules for the procedures for assessment of conformity, suitability for use and EC verification to be used in the technical specifications for interoperability adopted under Directive 2008/57/EC of the European Parliament and of the Council (OJ L 319, 4.12.2010, p. 1).'

#### Article 2

The texts of Decision 2010/713/EU in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

### Article 3

This Decision shall enter into force on 1 October 2011, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee\*, or on the day of the entry into force of the Decision of the EEA Joint Committee incorporating Decision No 768/2008/EC of the European Parliament and of the Council<sup>3</sup> into the Agreement, whichever is the later.

## Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
