

DECISION OF THE EEA JOINT COMMITTEE

No 192/2012

of 26 October 2012

amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Regulation (EU) No 200/2012 of 8 March 2012 concerning a Union target for the reduction of *Salmonella enteritidis* and *Salmonella typhimurium* in flocks of broilers, as provided for in Regulation (EC) No 2160/2003 of the European Parliament and of the Council⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Regulation (EU) No 233/2012 of 16 March 2012 implementing Regulation (EC) No 999/2001 of the European Parliament and of the Council as regards the approval of the amended national scrapie control programme for Denmark⁽²⁾ is to be incorporated into the EEA Agreement.
- (3) Commission Implementing Decision 2011/825/EU of 8 December 2011 amending Decision 2010/221/EU as regards national measures for preventing the introduction of certain aquatic animal diseases into parts of Ireland, Finland and Sweden⁽³⁾ is to be incorporated into the EEA Agreement.
- (4) Commission Implementing Decision 2012/111/EU of 10 February 2012 amending Decision 2007/453/EC as regards the BSE status of Denmark and Panama⁽⁴⁾ is to be incorporated into the EEA Agreement.
- (5) Regulation (EU) No 200/2012 repeals Commission Regulation (EC) No 646/2007⁽⁵⁾ which is incorporated into the EEA Agreement and which is consequently to be repealed under the EEA Agreement.
- (6) This Decision concerns legislation regarding veterinary matters. Legislation regarding veterinary matters shall not apply to Liechtenstein as long as the application of the Agreement between the European Community and the Swiss Confederation on trade in agricultural products is extended to Liechtenstein, as specified in the sectoral adaptations to Annex I to the EEA Agreement. This Decision is therefore not to apply to Liechtenstein.
- (7) Annex I to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Chapter I of Annex I to the EEA Agreement shall be amended as follows:

- (1) the following indent shall be added in point 94 (Commission Decision 2010/221/EU) in Part 4.2:

'— **32011 D 0825**: Commission Implementing Decision 2011/825/EU of 8 December 2011 (OJ L 328, 10.12.2011, p. 53).';
- (2) the text of point 47 (Commission Regulation (EC) No 646/2007) in Part 7.2 shall be deleted;
- (3) the following indent shall be added in point 49 (Commission Decision 2007/453/EC) in Part 7.2:

'— **32012 D 0111**: Commission Implementing Decision 2012/111/EU of 10 February 2012 (OJ L 50, 23.2.2012, p. 49).';
- (4) the following points shall be inserted after point 56 (Commission Implementing Regulation (EU) No 931/2011) in Part 7.2:

'57. **32012 R 0200**: Commission Regulation (EU) No 200/2012 of 8 March 2012 concerning a Union target for the reduction of *Salmonella enteritidis* and *Salmonella typhimurium* in flocks of broilers, as provided for in Regulation (EC) No 2160/2003 of the European Parliament and of the Council (OJ L 71, 9.3.2012, p. 31).

58. **32012 R 0233**: Commission Implementing Regulation (EU) No 233/2012 of 16 March 2012 implementing Regulation (EC) No 999/2001 of the European Parliament and of the Council as regards the approval of the amended national scrapie control programme for Denmark (OJ L 78, 17.3.2012, p. 13).'

Article 2

The texts of Regulation (EU) No 200/2012 and Implementing Regulation (EU) No 233/2012 and Implementing Decisions 2011/825/EU and 2012/111/EU in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 1 November 2012, provided that all the notifications under Article 103(1) of the EEA Agreement have been made to the EEA Joint Committee (*).
