

DECISION OF THE EEA JOINT COMMITTEE**No 97/2014****of 16 May 2014****amending Annex XIII (Transport) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) No 1103/2013 of 6 November 2013 amending Regulation (EU) No 185/2010 as regards recognising the equivalence of security standards of third countries ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Regulation (EU) No 1116/2013 of 6 November 2013 amending Regulation (EU) No 185/2010 as regards clarification, harmonisation and simplification of certain specific aviation security measures ⁽²⁾ is to be incorporated into the EEA Agreement.
- (3) Commission Implementing Decision 2013/7275/EU of 6 November 2013 amending Commission Decision C (2010) 774 as regards clarification, harmonisation and simplification of certain specific aviation security measures is to be incorporated into the EEA Agreement.
- (4) Annex XIII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XIII to the EEA Agreement shall be amended as follows:

- (1) the following indents are added in point 66he (Commission Regulation (EU) No 185/2010):

- **32013 R 1103:** Commission Implementing Regulation (EU) No 1103/2013 of 6 November 2013 (OJ L 296, 7.11.2013, p. 6),
- **32013 R 1116:** Commission Implementing Regulation (EU) No 1116/2013 of 6 November 2013 (OJ L 299, 9.11.2013, p. 1).;

- (2) the following indent is added in point 66hf (Commission Decision C (2010) 774 final):

- **32013 D 7275:** Commission Implementing Decision 2013/7275/EU of 6 November 2013 amending Commission Decision C(2010) 774 as regards clarification, harmonisation and simplification of certain specific aviation security measures.'

Article 2

The texts of Implementing Regulations (EU) No 1103/2013 and (EU) No 1116/2013 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 17 May 2014, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).
