

DECISION OF THE EEA JOINT COMMITTEE
No 104/2014
of 16 May 2014
amending Annex XXI (Statistics) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Regulation (EU) No 830/2011 of 27 July 2011 establishing for 2011 the 'Prodcom list' of industrial products provided for by Council Regulation (EEC) No 3924/91 ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Commission Regulation (EU) No 907/2012 of 20 August 2012 establishing for 2012 the 'Prodcom list' of industrial products provided for by Council Regulation (EEC) No 3924/91 ⁽²⁾ is to be incorporated into the EEA Agreement.
- (3) Commission Regulation (EU) No 936/2013 of 12 September 2013 establishing for 2013 the 'Prodcom list' of industrial products provided for by Council Regulation (EEC) No 3924/91 ⁽³⁾ is to be incorporated into the EEA Agreement.
- (4) Annex XXI to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

The following points are inserted after point 4ai (Commission Regulation (EU) No 860/2010) of Annex XXI to the EEA Agreement:

- '4aj. **32011 R 0830:** Commission Regulation (EU) No 830/2011 of 27 July 2011 establishing for 2011 the "Prodcom list" of industrial products provided for by Council Regulation (EEC) No 3924/91 (OJ L 224, 30.8.2011, p. 1).
- 4ak. **32012 R 0907:** Commission Regulation (EU) No 907/2012 of 20 August 2012 establishing for 2012 the "Prodcom list" of industrial products provided for by Council Regulation (EEC) No 3924/91 (OJ L 276, 10.10.2012, p. 1).
- 4al. **32013 R 0936:** Commission Regulation (EU) No 936/2013 of 12 September 2013 establishing for 2013 the "Prodcom list" of industrial products provided for by Council Regulation (EEC) No 3924/91 (OJ L 271, 11.10.2013, p. 1).'

Article 2

The texts of Regulations (EU) No 830/2011, (EU) No 907/2012 and (EU) No 936/2013, in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 17 May 2014, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).
