

**DECISION OF THE EEA JOINT COMMITTEE**  
**No 162/2015**  
**of 11 June 2015**  
**amending Annex XIII (Transport) to the EEA Agreement [2016/2197]**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2015/187 of 6 February 2015 amending Regulation (EU) No 185/2010 as regards the screening of cabin baggage <sup>(1)</sup> is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Decision C(2015) 561 of 6 February 2015 amending Commission Decision C(2010) 774 as regards the screening of cabin baggage is to be incorporated into the EEA Agreement.
- (3) Commission Implementing Decision C(2015) 984 of 19 February 2015 amending Commission Decision C(2010) 774 laying down measures for the implementation of the common basic standards on aviation security in respect of air cargo and mail transported into the Union is to be incorporated into the EEA Agreement.
- (4) Annex XIII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

*Article 1*

Annex XIII to the EEA Agreement shall be amended as follows:

1. The following indent is added in point 66he (Commission Regulation (EU) No 185/2010):

‘— **32015 R 0187**: Commission Implementing Regulation (EU) 2015/187 of 6 February 2015 (OJ L 31, 7.2.2015, p. 18).’

2. The following indents are added in point 66hf (Commission Decision C(2010) 774 final):

‘— **32015 D 0561**: Commission Implementing Decision C(2015) 561 of 6 February 2015 amending Commission Decision C(2010) 774 as regards the screening of cabin baggage.

— **32015 D 0984**: Commission Implementing Decision C(2015) 984 of 19 February 2015 amending Commission Decision C(2010) 774 laying down measures for the implementation of the common basic standards on aviation security in respect of air cargo and mail transported into the Union.’

*Article 2*

The texts of Implementing Regulation (EU) 2015/187 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.
