DECISION OF THE EEA JOINT COMMITTEE

No 247/2017

of 15 December 2017

amending Annex XX (Environment) to the EEA Agreement [2019/1653]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof.

Whereas:

- (1) Commission Delegated Regulation (EU) 2017/1499 of 2 June 2017 amending Annexes I and II to Regulation (EU) No 510/2011 of the European Parliament and of the Council for the purpose of adapting them to the change in the regulatory test procedure for the measurement of CO_2 from light commercial vehicles (1) is to be incorporated into the EEA Agreement.
- (2) Commission Delegated Regulation (EU) 2017/1502 of 2 June 2017 amending Annexes I and II to Regulation (EC) No 443/2009 of the European Parliament and of the Council for the purpose of adapting them to the change in the regulatory test procedure for the measurement of CO₂ from light duty vehicles (²) is to be incorporated into the EEA Agreement.
- (3) Annex XX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Chapter III of Annex XX to the EEA Agreement shall be amended as follows:

- 1. The following indent is added in point 21ae (Regulation (EC) No 443/2009 of the European Parliament and of the Council):
 - '— 32017 R 1502: Commission Delegated Regulation (EU) 2017/1502 of 2 June 2017 (OJ L 221, 26.8.2017, p. 4).'
- 2. The following indent is added in point 21ay (Regulation (EU) No 510/2011 of the European Parliament and of the Council):
 - '— 32017 R 1499: Commission Delegated Regulation (EU) 2017/1499 of 2 June 2017 (OJ L 219, 25.8.2017, p. 1).'

Article 2

The texts of Delegated Regulations (EU) 2017/1499 and (EU) 2017/1502 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.
