

DECISION OF THE EEA JOINT COMMITTEE
No 9/2020

of 7 February 2020

**amending Annex II (Technical regulations, standards, testing and certification) to the
EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”),
and in particular Article 98 thereof,

Whereas:

- (1) Commission Delegated Directive (EU) 2019/1845 of 8 August 2019 amending, for the purposes of adapting to scientific and technical progress, Annex III to Directive 2011/65/EU of the European Parliament and of the Council as regards an exemption for bis(2-ethylhexyl) phthalate (DEHP) in certain rubber components used in engine systems¹ is to be incorporated into the EEA Agreement.
- (2) Commission Delegated Directive (EU) 2019/1846 of 8 August 2019 amending, for the purposes of adapting to scientific and technical progress, Annex III to Directive 2011/65/EU of the European Parliament and of the Council as regards an exemption for lead in solders used in certain combustion engines² is to be incorporated into the EEA Agreement.
- (3) Annex II to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

The following indents are added in point 12q (Directive 2011/65/EU of the European Parliament and of the Council) of Chapter XV of Annex II to the EEA Agreement:

- ‘- **32019 L 1845**: Commission Delegated Directive (EU) 2019/1845 of 8 August 2019 (OJ L 283, 5.11.2019, p. 38),
- **32019 L 1846**: Commission Delegated Directive (EU) 2019/1846 of 8 August 2019 (OJ L 283, 5.11.2019, p. 41).’

Article 2

The texts of Delegated Directives (EU) 2019/1845 and (EU) 2019/1846 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.
