DECISION OF THE COUNCIL NO 1 OF 2012

(Adopted at the 2nd meeting on 22 March 2012)

AMENDMENT TO THE APPENDIX TO ANNEX Q TO THE CONVENTION

AIR TRANSPORT

THE COUNCIL,

Having regard to the Member States' endeavour to regularly update the Convention in order to take account of developments under the Agreement on the European Economic Area and the bilateral Agreements of 21 June 1999 between the Swiss Confederation on the one hand and the European Community and its Member States on the other,

Having regard to Article 53(3) of the Convention, empowering the Council to amend the Appendix to Annex Q to the Convention,

Having regard to the recommendation of the Committee on Air Transport in its report to the Council to amend the Appendix to Annex Q (Air transport) to the Convention,

DECIDES:

1. The Appendix to Annex Q to the Convention shall be amended as follows:
 - a) The following shall be deleted in point 1 (Third aviation package of liberalisation and other civil aviation rules):

'No 2407/92

Council Regulation of 23 July 1992 on licensing of air carriers.

(Articles 1-18; as regards the application of Article 13(3), the reference to Article 226 of the EC Treaty shall be understood to mean a reference to the applicable procedures of this Annex)

No 2408/92

Council Regulation of 23 July 1992 on access for Community air carriers to intra-Community air routes, as amended by:

- **1 03 T:** Act concerning the conditions of accession of the Czech Republic, the Republic of Estonia, the Republic of Cyprus, the Republic of Latvia, the Republic of Lithuania, the Republic of Hungary, the Republic of Malta, the Republic of Poland, the Republic of Slovenia and the Slovak Republic and the adjustments to the Treaties on which the European Union is founded adopted on 16 April 2003 (OJ L 236, 23.9.2003, p. 33).

(Articles 1-10, 12-15)

The provisions of the Regulation shall, for the purposes of this Convention, be read with the following adaptation:

The Annexes to the Regulation shall include only airports in the EFTA States.

- d) The following shall be inserted in point 3 (Air Safety) after the reference to Commission Regulation (EU) No 127/2010:

'No 962/2010

Commission Regulation of 26 October 2010 amending Regulation (EC) No 2042/2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks.

No 390/2011

Commission Implementing Regulation of 19 April 2011 amending Regulation (EC) No 474/2006 establishing the Community list of air carriers which are subject to an operating ban within the Community.'

- e) The following shall be inserted in point 4 (Aviation Security) after the reference to Commission Regulation (EU) No 358/2010:

'No 573/2010

Commission Regulation of 30 June 2010 amending Regulation (EU) No 185/2010 laying down detailed measures for the implementation of the common basic standards on aviation security.

No 334/2011

Commission Regulation of 7 April 2011 amending Regulation (EU) No 185/2010 laying down detailed measures for the implementation of the common basic standards on aviation security.

Commission Regulation of 25 March 2010 laying down common rules on air traffic flow management.

The provisions of this Regulation shall, for the purposes of this Convention, be read with the following adaptation:

This Regulation shall not apply to Liechtenstein.

Commission Regulation of 18 October 2010 amending Regulation (EC) No 1033/2006 as regards the ICAO provisions referred to in Article 3(1).

No 283/2011

Commission Regulation of 22 March 2011 amending Regulation (EC) No 633/2007 as regards the transitional arrangements referred to in Article 7.’
