DECISION OF THE COUNCIL NO 4 OF 2012

(Adopted at the 8th meeting on 6 November 2012)

AMENDMENT TO THE APPENDIX TO ANNEX Q TO THE CONVENTION

AIR TRANSPORT

THE COUNCIL,

Having regard to the Member States' endeavour to regularly update the Convention in order to take account of developments under the Agreement on the European Economic Area and the bilateral Agreements of 21 June 1999 between the Swiss Confederation on the one hand and the European Community and its Member States on the other,

Having regard to Article 53(3) of the Convention, empowering the Council to amend the Appendix to Annex Q to the Convention,

Having regard to the recommendation of the Committee on Air Transport in its report to the Council to amend the Appendix to Annex Q (Air transport) to the Convention,

DECIDES:

1. The Appendix to Annex Q to the Convention shall be amended as follows:
 - a) The following shall be inserted in point 1 (Third aviation package of liberalisation and other civil aviation rules) after the reference to Regulation (EC) No 1008/2008 of the European Parliament and of the Council:

'No 2009/12
Directive of the European Parliament and of the Council of 11 March 2009 on airport charges.

The provisions of the Directive shall, for the purposes of this Convention, be read with the following adaptation:

This Directive shall not apply to Liechtenstein.’

- b) The following shall be deleted in point 3 (Air Safety):

‘No 390/2011

Commission Implementing Regulation of 19 April 2011 amending Regulation (EC) No 474/2006 establishing the Community list of air carriers which are subject to an operating ban within the Community.’

- c) The following shall be inserted in point 3 (Air Safety) after the reference to Commission Regulation (EU) No 962/2010:

‘No 295/2012

Commission Implementing Regulation of 3 April 2012 amending Regulation (EC) No 474/2006 establishing the Community list of air carriers which are subject to an operating ban within the Community.’

- d) The following shall be inserted in point 4 (Aviation Security) after the reference to Commission Decision No 9139/2010:

‘No 983/2010

Commission Regulation of 3 November 2010 amending Regulation (EU) No 185/2010 laying down detailed measures for the implementation of the common basic standards on aviation security.

No 1087/2011

Commission Implementing Regulation of 27 October 2011 amending Regulation (EU) No 185/2010 laying down detailed measures for the implementation of the common basic standards on aviation security in respect of explosive detection systems.

No 1141/2011

Commission Regulation of 10 November 2011 amending Regulation (EC) No 272/2009 supplementing the common basic standards on civil aviation security as regards the use of security scanners at EU airports.

No 1147/2011

Commission Implementing Regulation of 11 November 2011 amending Regulation (EU) No 185/2010 implementing the common basic standards on civil aviation security as regards the use of security scanners at EU airports.

No 8042/2011

Commission Decision of 14 November 2011 amending Commission Decision 2010/774/EU of 13 April 2010 laying down detailed measures for the implementation of the common basic standards on aviation security as regards the use of security scanners at EU airports.’

2. This Decision shall take immediate effect.
