FISH AND OTHER MARINE PRODUCTS

Article 1

1. Fish and other marine products, as listed in Table 1 below, are covered by the provisions of this Agreement, unless otherwise provided for in this Annex.
2. Upon the date of entry into force of this Agreement all customs duties on imports and charges having equivalent effect shall be abolished for products listed in Table 1 originating in an EFTA State or in Jordan, unless otherwise specified in Articles 2 and 3 of this Annex.

Article 2

Jordan shall progressively abolish customs duties and charges having equivalent effect for products originating in an EFTA State and listed in Table 2 below in accordance with the following timetable:

Upon entry into force of this Agreement:	to 80 % of the basic duty or charge
One year after the entry into force of this Agreement:	to 40 % of the basic duty or charge
Two years after the entry into force of this Agreement:	to 20 % of the basic duty or charge
Three years after the entry into force of this Agreement:	to zero.
