PROCESSED AGRICULTURAL PRODUCTS

Article 1ⁱ

Tariff Concessions between Iceland, Norway and Turkey

1. Iceland and Norway shall accord for processed agricultural products listed in Table 1 to this Annex, originating in Turkey, treatment no less favourable than that accorded to the European Union (EU).ⁱⁱ
2. Turkey shall accord for processed agricultural products listed in Table 1 to this Annex, originating in Iceland and Norway, treatment no less favourable than that accorded to the EU.ⁱⁱⁱ

Article 2

Tariff Concessions between Switzerland and Turkey

1. Switzerland shall accord for processed agricultural products originating in Turkey, preferential treatment as indicated in Table 2 to this Annex.
2. Turkey shall accord for processed agricultural products originating in Switzerland, preferential treatment as indicated in Table 3 to this Annex.

Article 3

Notification

1. The EFTA States shall publish or provide links to nationally published applicable import duties for processed agricultural products on the website of the EFTA Secretariat.
2. Turkey shall publish the applicable import duties for processed agricultural products on its official website.

ⁱ The preferential quotas exchanged with the EU shall be out of the scope of this Article.

ⁱⁱ For greater certainty, the customs duties applied to the products listed in Table 1 originating in Turkey shall not be more than the ones accorded for the same product originating in the EU.

ⁱⁱⁱ For greater certainty, the customs duties applied to the products listed in Table 1 originating in Norway and Iceland shall not be more than the ones accorded for the same product originating in the EU.

Article 4

Consultations

The EFTA States and Turkey shall review periodically the development of their trade in products covered by this Annex. In the light of these reviews, and taking into account the arrangements between the Parties and the EU, as well as the Parties' respective WTO commitments, the EFTA States and Turkey may decide on possible changes to this Annex.
