# DECISION OF THE EEA JOINT COMMITTEE No 89/2007

## of 6 July 2007

# amending Annex XIII (Transport) to the EEA Agreement

### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

### Whereas:

- Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee (1) No 54/2007 of 8 June 2007<sup>1</sup>.
- (2) Directive 2006/87/EC of the European Parliament and of the Council of 12 December 2006 laying down technical requirements for inland waterway vessels and repealing Council Directive 82/714/EEC<sup>2</sup> is to be incorporated into the Agreement.
- (3) Directive 2006/137/EC of the European Parliament and of the Council of 18 December 2006 amending Directive 2006/87/EC laying down technical requirements for inland waterway vessels<sup>3</sup> is to be incorporated into the Agreement,
- Directive 2006/87/EC repeals, with effect from 30 December 2008, Council Directive (4) 82/714/EEC<sup>4</sup>, which is incorporated into the Agreement and which is consequently to be repealed under the Agreement with effect from 30 December 2008,

## HAS DECIDED AS FOLLOWS:

### Article 1

Annex XIII to the Agreement shall be amended as follows:

1. The following point shall be inserted after point 47 (Council Directive 82/714/EEC):

waterway vessels and repealing Council Directive 82/714/EEC (OJ L 389, 30.12.2006, p. 1), as amended by:

- 32006 L 0137: Directive 2006/137/EC of the European Parliament and of the Council of 18 December 2006 (OJ L 389, 30.12.2006, p. 261).'
- 2. The text of point 47 (Council Directive 82/714/EEC) shall be deleted with effect from 30 December 2008.

#### Article 2

The texts of Directives 2006/87/EC and 2006/137/EC in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

### Article 3

This Decision shall enter into force on 7 July 2007, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee\*.

#### Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
