DECISION OF THE EEA JOINT COMMITTEE No 14/2009

of 5 February 2009

amending Annex XIII (Transport) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee (1) No 129/2008 of 5 December 2008 ¹.
- Directive 2004/36/EC of the European Parliament and of the Council of 21 April 2004 (2) on the safety of third-country aircraft using Community airports² was incorporated into the Agreement by Decision of the EEA Joint Committee No 152/2005³ of 2 December 2005, with country specific adaptations.
- (3) Commission Directive 2008/49/EC of 16 April 2008 amending Annex II to Directive 2004/36/EC of the European Parliament and of the Council regarding the criteria for the conduct of ramp inspections on aircraft using Community airports⁴ is to be incorporated into the Agreement.
- Commission Regulation (EC) No 351/2008 of 16 April 2008 implementing Directive (4) 2004/36/EC of the European Parliament and of the Council as regards the prioritisation of ramp inspections on aircraft using Community airports⁵ is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Annex XIII to the Agreement shall be amended as follows:
