# DECISION OF THE EEA JOINT COMMITTEE No 100/2009

# of 25 September 2009

# amending Annex XIII (Transport) to the EEA Agreement

## THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

## Whereas:

- (1) Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee 85/2009 of 3 July 2009<sup>1</sup>.
- Regulation (EC) No 549/2004 of the European Parliament and of the Council of 10 March 2004 laying down the framework for the creation of the single European sky², Regulation (EC) No 550/2004 of the European Parliament and of the Council of 10 March 2004 on the provision of air navigation services in the single European sky³, Regulation (EC) No 551/2004 of the European Parliament and of the Council of 10 March 2004 on the organisation and use of the airspace in the single European sky⁴, and Regulation (EC) No 552/2004 of the European Parliament and of the Council of 10 March 2004 on the interoperability of the European Air Traffic Management network⁵ were incorporated into the Agreement by Decision of the EEA Joint Committee No 67/2006⁶ of 2 June 2006, with country specific adaptations.
- (3) Commission Regulation (EC) No 30/2009 of 16 January 2009 amending Regulation (EC) No 1032/2006 as far as the requirements for automatic systems for the exchange of flight data supporting data link services are concerned is to be incorporated into the Agreement,

## HAS DECIDED AS FOLLOWS:

#### Article 1

The following shall be added in point 66wb (Commission Regulation (EC) No 1032/2006) of Annex XIII to the Agreement:

- **32009 R 0030**: Commission Regulation (EC) No 30/2009 of 16 January 2009 (OJ L 13, 17.1.2009, p. 20).'

#### Article 2

The texts of Regulation (EC) No 30/2009 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

## Article 3

This Decision shall enter into force on 26 September 2009, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee\*.

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
