# DECISION OF THE EEA JOINT COMMITTEE No 73/2010

#### of 11 June 2010

# amending Annex XIII (Transport) to the EEA Agreement

#### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

#### Whereas:

- (1) Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee No 51/2010 of 30 April 2010<sup>1</sup>.
- (2) Commission Regulation (EC) No 536/2008 of 13 June 2008 giving effect to Article 6(3) and Article 7 of Regulation (EC) No 782/2003 of the European Parliament and of the Council on the prohibition of organotin compounds on ships and amending that Regulation<sup>2</sup> is to be incorporated into the Agreement,

#### HAS DECIDED AS FOLLOWS:

#### Article 1

Annex XIII to the Agreement shall be amended as follows:

- 1. The following shall be added in point 56p (Regulation (EC) No 782/2003 of the European Parliament and of the Council):
  - ', as amended by:
  - **32008 R 0536**: Commission Regulation (EC) No 536/2008 of 13 June 2008 (OJ L 156, 14.6.2008, p. 10).'
- 2. The following point shall be inserted after point 56p (Regulation (EC) No 782/2003 of the European Parliament and of the Council):
  - '56pa.**32008 R 0536**: Commission Regulation (EC) No 536/2008 of 13 June 2008 giving effect to Article 6(3) and Article 7 of Regulation (EC) No 782/2003 of the European Parliament and of the Council on the prohibition of organotin

compounds on ships and amending that Regulation (OJ L 156, 14.6.2008, p. 10).'

### Article 2

The texts of Regulation (EC) No 536/2008 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

## Article 3

This Decision shall enter into force on 12 June 2010, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee.\*

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
