DECISION OF THE EEA JOINT COMMITTEE No 9/2011

of 1 April 2011

amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex I to the Agreement was amended by Decision of the EEA Joint Committee No 116/2010 of 10 November 2010¹.
- (2) Regulation (EC) No 767/2009 of the European Parliament and of the Council of 13 July 2009 on the placing on the market and use of feed, amending European Parliament and Council Regulation (EC) No 1831/2003 and repealing Council Directive 79/373/EEC, Commission Directive 80/511/EEC, Council Directives 82/471/EEC, 83/228/EEC, 93/74/EEC, 93/113/EC and 96/25/EC and Commission Decision 2004/217/EC² is to be incorporated into the Agreement.
- (3) Commission Regulation (EU) No 242/2010 of 19 March 2010 creating the Catalogue of feed materials³ is to be incorporated into the Agreement.
- (4) Commission Regulation (EU) No 454/2010 of 26 May 2010 on transitional measures under Regulation (EC) No 767/2009 of the European Parliament and of the Council as regards the labelling provisions for feed⁴ is to be incorporated into the Agreement.
- (5) Regulation (EC) No 767/2009 repeals Council Directive 79/373/EEC⁵, Commission Directive 80/511/EEC⁶, Council Directives 82/471/EEC⁷, 83/228/EEC⁸, 93/74/EEC⁹, 93/113/EC¹⁰ and 96/25/EC¹¹ and Commission Decision 2004/217/EC¹² which have

been incorporated into the Agreement and are therefore to be repealed under the Agreement.

(6) This Decision is not to apply to Liechtenstein,

HAS DECIDED AS FOLLOWS:

Article 1

Chapter II of Annex I to the Agreement shall be amended as follows:

- 1. The following indent shall be added in point 1a (Regulation (EC) No 1831/2003 of the European Parliament and of the Council):
 - '- **32009 R 0767**: Regulation (EC) No 767/2009 of the European Parliament and of the Council of 13 July 2009 (OJ L 229, 1.9.2009, p. 1).
- 2. The text of points 3 (Council Directive 93/113/EC), 5 (Council Directive 79/373/EEC), 8 (Council Directive 93/74/EEC), 11 (Commission Directive 80/511/EEC), 14a (Council Directive 96/25/EC), 14b (Commission Decision 2004/217/EC), 15 (Council Directive 82/471/EEC) and 16 (Council Directive 83/228/EEC) shall be deleted.
- 3. The following shall be inserted after point 47 (Commission Regulation (EC) No 669/2009):

'Placing on the market and use of feed
