

DECISION OF THE EEA JOINT COMMITTEE
No 98/2011

of 30 September 2011

amending Annex XI (Electronic communication, audiovisual services and information society) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as ‘the Agreement’, and in particular Article 98 thereof,

Whereas:

- (1) Annex XI to the Agreement was amended by Decision of the EEA Joint Committee No 79/2011 of 1 July 2011¹.
- (2) Commission Decision 2009/343/EC of 21 April 2009 amending Decision 2007/131/EC on allowing the use of the radio spectrum for equipment using ultra-wideband technology in a harmonised manner in the Community² is to be incorporated into the Agreement.
- (3) Commission Decision 2009/381/EC of 13 May 2009 amending Decision 2006/771/EC on harmonisation of the radio spectrum for use by short-range devices³ is to be incorporated into the Agreement,

HAS ADOPTED THIS DECISION:

Article 1

Annex XI to the Agreement shall be amended as follows:

1. The following shall be added in point 5cw (Commission Decision 2007/131/EC)
, as amended by:
 - **32009 D 0343**: Commission Decision 2009/343/EC of 21 April 2009 (OJ L 105, 25.4.2009, p. 9).’

2. The following indent shall be added in point 5cz (Commission Decision 2006/771/EC):

‘- **32009 D 0381**: Commission Decision 2009/381/EC of 13 May 2009 (OJ L 119, 14.5.2009, p. 32).’

Article 2

The texts of Decisions 2009/343/EC and 2009/381/EC in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 1 October 2011, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee*.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
