

DECISION OF THE EEA JOINT COMMITTEE

No 82/2012

of 30 April 2012

amending Annex II (Technical regulations, standards, testing and certification) to the EEA Agreement

THE EEA JOINT COMMITTEE,

(1) the text of point 49 (Council Directive 89/396/EEC) shall be deleted;

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

(2) the following point shall be inserted after point 66 (Commission Implementing Regulation (EU) No 1274/2011):

Whereas:

(1) Annex II to the Agreement was amended by Decision of the EEA Joint Committee No 45/2012 of 30 March 2012 ⁽¹⁾.

'67. **32011 L 0091**: Directive 2011/91/EU of the European Parliament and of the Council of 13 December 2011 on indications or marks identifying the lot to which a foodstuff belongs (OJ L 334, 16.12.2011, p. 1).'

(2) Directive 2011/91/EU of the European Parliament and of the Council of 13 December 2011 on indications or marks identifying the lot to which a foodstuff belongs ⁽²⁾ is to be incorporated into the Agreement.

Article 2

The text of Directive 2011/91/EU in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

(3) Directive 2011/91/EU repeals Council Directive 89/396/EEC ⁽³⁾, which is incorporated into the Agreement, and which is consequently to be repealed under the Agreement.

Article 3

This Decision shall enter into force on 1 May 2012, provided that all the notifications under Article 103(1) of the Agreement have been made to the EEA Joint Committee (*).

(4) This Decision concerns legislation regarding foodstuffs. Legislation regarding foodstuffs shall not apply to Liechtenstein as long as the application of the Agreement between the European Community and the Swiss Confederation on trade in agricultural products is extended to Liechtenstein, as specified in the introduction to Chapter XII of Annex II to the Agreement. This Decision is therefore not to apply to Liechtenstein,

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.

HAS ADOPTED THIS DECISION:

Article 1

Chapter XII of Annex II to the Agreement shall be amended as follows:
